GAAB LOCKS LLC warrants that the products it manufactures and sells will be free of defects in material and workmanship for a period as follows:

1. Period:

Five years warranty, for the following products:

2. Electrified exit devices and other electrified products including electronic material: 12 months after the billing date.

3. The Purchaser must prove the product acquisition by documentation specifying the number and date of production to Gaab, from now on the Company, for its review and then proceeding with the claim.

4. This warranty applies to all countries where the products are distributed by the Company or an authorized distributor.

5. The Company warrants the product as it is installed and used to the purpose that it has been designed.

Moreover, it must be manipulated by qualified personnel following the installation manual attached to the product.

6. The Purchaser shall be obligated to promptly report any failure to conform to this limited warranty, in writing, to the Company within said limited warranty period, whereupon the Company shall, at its option, correct such nonconformity:

a) by suitable repair to such product.

b) furnish a replacement part.

For both cases the repair or replacement will take place in the Company's facility. Both cases apply as the product has been stored, installed, maintained and operated such product in accordance with good industry practices and has complied with specific recommendations of the Company.

7. Accessories or product furnished by the Company, but manufactured by others, shall carry whatever warranty the manufacturers have conveyed to the Company and which can be passed on to the Purchaser.

8. The Company shall not be liable for any repairs, replacements, or adjustments to the product or any costs of labor performed by the Purchaser or others without the Company's prior written approval.

9. The effects of corrosion and erosion, as well as the wear made by the normal use of the product, are expressly excluded from this warranty.

10. The Company makes no other warranty or representation of any kind whatsoever, expressed or implied, except that of title, and all implied warranties of merchantability and fitness for a particular purpose, are hereby disclaimed. No agent, representative, dealer, or employee of Company has the authority to increase or alter the obligations of this limited warranty. The Purchaser shall not operate product which is considered to be defective, without first notifying the Company in writing of its intention to do so. Any such use of product will be at the Purchaser's sole risk and liability and will not be covered by this limited warranty
